Privacy Objectives

We take your privacy very seriously. Please read this privacy statement carefully as it contains important information on who we are and how and why we collect, store, use and share your personal data. It also explains your rights in relation to your personal data and how to contact us or supervisory authorities in the event you have a complaint.

Definitions

Data Collection

- We collect, use and are responsible for certain personal data about you.
- When we do so we are subject to the UK General Data Protection Regulation (UK GDPR).
- We are also subject to the EU General Data Protection Regulation (EU GDPR) in relation to goods and services we offer to individuals and our wider operations in the European Economic Area (EEA).

Personal Data We Collect about You

- We may collect and use the following personal data about you:
 - o Your name and contact information, including email address and telephone number and company details
 - o Information to check and verify your identity, e.g. your date of birth, nationality, etc.
 - Location data,
 - Your billing information, transaction and payment card information
 - o Your professional interests
 - O Your professional online presence, e.g. LinkedIn profile
 - o Information to enable us to undertake credit or other financial checks on you
 - o Your responses to surveys, competitions, and promotions
- We collect and use this personal data to provide services to you or to work with you. If you do not provide personal data we ask for, it may delay or prevent us from providing services to you.

How Your Personal Data is Collected

ESGLOBAL

- We collect most of this personal data directly from you-in person, by telephone, text or email and/or via our websites.
- However, we may also collect information:
 - o From publicly accessible sources (e.g. Companies House, your company website, or HM Land Registry);
 - o Directly from a third party, e.g.:
 - Sanctions screening providers.
 - Credit reference agencies.
 - Customer due diligence providers.
 - Sub-contractors.
 - Suppliers.
 - From a third party with your consent, (eg your bank or your employer)
 - Via our IT systems.

How and Why We Use Your Personal Data

- When we use your personal information we are required to have a legal basis for doing so. There are various different legal bases on which we may rely, depending on what personal information we process and why.
- The legal bases we may rely on include:
 - o Consent: where you have given us clear consent for us to process your personal information for a specific purpose
 - Contract: where our use of your personal information is necessary for a contract we have with you, or because you have asked us to take specific steps before entering into a contract
 - Legal Obligation: where our use of your personal information is necessary for us to comply with the law (not including contractual obligations)
 - Legitimate Interests: where our use of your personal information is necessary for our legitimate interests or the legitimate interests of a third party (unless there is a good reason to protect your personal information which overrides our legitimate interests)
- The table below explains what we use your personal data for and why.

- . Where we process special category personal data, we will also ensure we are permitted to do so under data protection laws, e.g.:
 - · Where we have your explicit consent.
 - The processing is necessary to protect your (or someone else's) vital interests where you are physically or legally incapable of giving consent; or
 - The processing is necessary to establish, exercise or defend legal claims.

Marketing

- We may use your personal data to send you updates (by email, text message, telephone or post) about our services, including exclusive offers, promotions or new services.
- We have a legitimate interest in using your personal data for marketing purposes (see above 'How and why we use your personal data').
 This means we do not usually need your consent to send you marketing information. However, where consent is needed, we will ask for this separately and clearly.
- You have the right to opt out of receiving marketing communications at any time by contacting us at info@es.global (info@es.global)
- We may ask you to confirm or update your marketing preferences if you ask us to provide further services in the future, or if there are changes in the law, regulation, or the structure of our business.
- We will always treat your personal data with the utmost respect and never sell it to other organizations for marketing purposes.

Who We Share Your Personal Data with

- We routinely share personal data with:
 - o Companies within the ES Global group
 - $\circ~$ Third parties we use to help deliver our services to you, (eg payment service providers,
 - Warehouses and delivery companies, sub-contractors, suppliers));
 - Other third parties we use to help us run our business, (eg marketing agencies or website hosts);
 - o Credit reference agencies;
 - o Our insurers and brokers;
 - Our banks;
- We only allow our service providers to handle your personal data if we are satisfied they take appropriate measures to protect your personal data.
- We also impose contractual obligations on service providers to ensure they can only use your personal data to provide services to us and to you.
- We may also need to:
 - o Share personal data with external auditors, eg in relation to ISO accreditation and or the audit of our accounts;
 - Disclose and exchange information with law enforcement agencies and regulatory bodies to comply with our legal and regulatory obligations;
 - Share some personal data with other parties, such as potential buyers of some or all of our business or during a restructuring—
 usually, information will be anonymized, but this may not always be possible. However, the recipient of the information will be bound
 by confidentiality obligations.

International Data Transfers

- Personal data may be transferred to countries outside the UK to enable users to travel and work in different locations on Company business
- Data is transferred outside the UK on the basis of a declaration of adequacy, binding corporate rules or other safeguards and link to relevant documents or other information if possible.

Where your Personal Data is Held

- Personal data may be held at our offices and those of our group companies, third party agencies, service providers, representatives and agents as described above (see above: 'Who we share your personal data with').
- Some of our group companies and third parties may be based outside the UK/EEA. For more information, including on how we safeguard your personal data when this happens, see 'International Data Transfers'.

How Long Your Personal Data will be Held

- We will keep your personal data while you have an account with us or we are providing services to you. Thereafter, we will keep your personal data for as long as is necessary:
 - ∘ To respond to any questions, complaints or claims made by you or on your behalf; to show that we treated you fairly;
 - o To keep records required by law.
- · We will not keep your personal data for longer than necessary. Different retention periods apply for different types of personal data.
- When it is no longer necessary to keep your personal data, we will delete or anonymize it.
